Prof. (Dr.)Anil G. Variath is an Adjunct Professor and Head of Post Graduate Legal Studies at MNLU Mumbai.

He has almost 30 years of experience in advocacy. He began his law practice in the courts of Kerala in 1987. After a brief stint he worked as an in-house legal counsel for two banks. He joined academics as a lecturer in Sidharth College of Law, in Mumbai between 2000-2006. Prof. Variath went to establish Law School at SNTD Women's University Mumbai and was its first Coordinator and Faculty in charge of the Law School between

2006-2009. From 2011 to 201, Prof. Variath assumed responsibility as the Principal of Sandesh law College, Vikhroli. During his tenure he has extended necessary support and guidance for establishing four law colleges in Mumbai.

In 2005, he established a law firm, M/s. Law Focus, which is expanded in Mumbai, Cochin, Trivandrum, New Delhi, Chennai and Bangalore.

Prof. Anil Variath also worked as a legal advisor to the Reserve Bank of India (2007), State Bank of India and Bank of India (2007-08), Punjab National Bank (2005), Dena Bank(2007), Syndicate Bank (2007), Andhra Bank(2007-08), Arcil ARC, Peagasus ARC, International ARC (2009) and many other corporate houses and the Enforcement Directorate (2009-10). He is a visiting faculty to the Officers' Training Colleges of Bank of India, PNB and Dena Bank till present.
