2. Candidates are requested to pay requisite fee of **Rs. 2,000/-** per application through electronic bank transfer NEFT/RTGS towards processing fee. Bank Details as well as the fee details are provided in **Annexure II**.
3. Applications will be considered strictly based on merit as per CLAT 2017 list of the candidates and fulfilling all the requirements as stated in this notification.
4. No other documents need be sent with the application form at the time of application.
5. The University shall not be responsible for any electronic delay in receipt of email.
6. Hostel accommodation is mandatory for students taking admission in B.A. LL.B. Programme of MNLU Mumbai.
7. The first indicative merit list of the selected candidates will be published on 12<sup>th</sup> July 2017.
